Objectif

L'objectif principal de ce séminaire est d'amener les étudiants à acquérir une solide connaissance du champ de l'administration et des politiques publiques, qui couvre l'étude des institutions et processus administratifs, des questions d'imputabilité, des principes de gestion et d'organisation, et des modes d'interactions entre l'État et la société dans le développement et la mise en oeuvre des décisions gouvernementales. Les étudiants pourront se familiariser aux différentes perspectives théoriques, démarches méthodologiques, acquis de recherche et débats qui marquent le champ.

Organisation

Le séminaire abordera les grandes tendances de la recherche et passera en revue, dans un ordre d'abord chronologique, certains des principaux ouvrages qui ont contribué à façonner le champ de l'administration et des politiques publiques. De façon générale, le thème de la *rationalité de l'action publique* servira de fil conducteur avec lequel les étudiants pourront suivre l'évolution et l'accumulation des connaissances à l'intérieur du champ. L'action publique doit-elle être guidée par une rationalité procédurale (ou légale) issue du processus politique, comme le pensait Max Weber au début du siècle dernier? Cela devrait-il être plutôt l'affaire d'une rationalité guidée par des principes scientifiques? Ou une rationalité façonnée par les principes du marché, les réseaux, les jeux de négociations pluralistes des groupes d'intérêts, les héritages institutionnels du passé, ou par l'apprentissage sociale et la délibération démocratique?

Évaluation

Pour aborder ces questions, les étudiants auront à lire des travaux importants de ce champ, à les analyser, critiquer et à échanger sur leurs mérites et limites. Chaque séminaire portera sur un certain nombre de lectures obligatoires autour d'un thème donné. Les étudiants seront invités à rédiger deux rapports critiques, comptant chacun pour 20% de la note finale. Les séminaires permettront d'approfondir la compréhension et l'analyse critique des textes. Les discussions seront lancées grâce à des présentations de la part des étudiants. Chaque étudiant devra préparer trois présentations, chacune comptant pour 10% de la

note finale. Un examen maison, comptant pour 30% de la note, permettra de faire la synthèse des différentes études.

Tous les textes dont la lecture est obligatoire sont à la réserve de la bibliothèque Samuel Bronfman ou au SRD du Département de science politique.
